- Annual Program Began in 2009
- Response to 20/20 Committee Recommendations:
  - Encourage New Volunteers; Previously Unengaged Residents
  - Community Outreach
  - Town Manager's Secret Motivation
- 10 Week Program, Two Hours Long, September December
- Most Municipal Departments and School Department Participates
- Limit to 30 Participants
- Concludes with 'Graduation' at Selectmen's Meeting

# **Program Announcement**

#### **Example:**

This year marks a decade for the Lexington Citizens' Academy! Citizens' Academy begins its tenth year in September and runs through early December. The program is designed to expose residents to the various Town departments so they can gain a better understanding of how municipal government works. Through presentations, discussions, and visits to Town departments, participants have the opportunity to hear from various Directors and Managers and learn about the operations of Town programs and services. It is intended as a two-way dialogue between Town staff and residents. Participants discover new opportunities for public involvement and the role they can play in Town government. Topics include Fire and Emergency Services, Schools, Public Works, Police, and Human Services, the Town Budget, Recreation Programming, Library Services, and more. The Academy is an annual town program, held once a week in the evenings, and enrolls approximately 30-35 residents. ## Time Dedicated to Citizens' Academy

# Recruitment and Programming\* 10-15 hours per week

Typically lasts for 5-8 weeks

#### **Timing Consists of**

- Development of the schedule for the year
- Recruitment for potential participants and development of the waitlist
- Sending advertisements for various community groups and media outlets

# Coordinating the Program 5-10 hours per week

Typically lasts for 10 weeks

#### Timing Consists of

- Weekly prep meetings with department managers and Town Staff
- Prep and set up for weekly sessions
- Attending and moderating each weekly session
- Sending notifications and updates to participants
- Receiving updates and following up on information for participants

<sup>\*</sup>Recruitment and development of Citizens' Academy typically takes place during the spring and summer. More time is typically allotted during this period



# **Budget Information**

Estimated Budget for Citizens' Academy

\$1,200 - \$1,500 Annual Budget\*

Costs include

- Food for participants | (estimated \$300 \$400 for entire session)
- Gifts for graduates | (\$750 \$800)
- Supplemental Materials (normally binders) | (\$150 \$200)

\*Figures vary due to the number of participants each year




# Benefits of the Citizens Academy
