3-31-2020 MMA Municipal CEO's Call:

Providing Sheltering for First Responders and the Homeless and Shelter Reimbursement

- What options are available to help municipalities set-up housing for public safety responders, health care workers, and homeless individuals who have tested positive for COVID-19?
- Massachusetts has received approval from FEMA to use hotels and dormitories for use as non-congregate shelters, and local governments may do so.
- Municipalities seeking to house first responders, health care workers, and the homeless in non-congregate settings are eligible for up to 75% reimbursement from the federal government, and may apply for said reimbursement through MEMA's Disaster Recovery Unit <u>here</u>.

- MEMA is currently exploring the use of dormitories for housing of first responders.
- The Covid Command Center (CCC), supported by MEMA, is taking numerous steps to provide housing for those who are homeless and need isolation, including: signing contracts with hotels; bringing in private security; and arranging for cleaning, feeding and all wrap-around services. CCC and MEMA are communicating with shelters regarding what assistance in most needed to support their caring for this population, and will provide resources.

Short Term Rentals and Hotels

- What restrictions on hotels and short term rentals have been issued?
 - Workers of lodging are considered essential only if the lodging is being offered or provided to accommodate the COVID-19 Essential Workforce, other workers responding to the COVID-19 public health emergency, and vulnerable populations
 - Guidance on the limited purposes and uses for which lodging is deemed essential has been issued and may be found <u>here</u>.

Public Records Requests

- Is there any consideration being given to possibly suspending the timeline mandated for fulfilling public record requests during the state of emergency?
 - The issue is on the Administration's radar, and solutions to this issue are being explored.

Municipal Permitting

- Does the municipal relief legislation pending also apply to citizens' petitions to amend zoning by-laws?
- Yes, the requirement that a planning board hold a hearing within 65 days of receiving a proposed zoning ordinance or by-law would be tolled until 45 days after the end of the emergency.

Municipal Finance

- What considerations have been given to providing select boards the authority to access their municipality's stabilization funds, use free cash outside of town meeting, and conduct year-end transfers?
- These are items which are being discussed and reviewed, and would require legislation.
- What update can be provided regarding changes to local aid and a new consensus revenue estimate?
- Conversations between Administration and Finance and the Legislature's Ways and Means Chairs are ongoing on this matter, and more information will be provided once available.
