### Recycling and Solid Waste Information for Municipal Officials on COVID-19

On March 10, 2020, Governor Baker declared a State of Emergency to support the Commonwealth's response to COVID 19. Since then, the Baker Administration has issued a number of additional Emergency Orders and guidance to support and inform this response. This document gathers together all of the guidance relative to solid waste and recycling issues for municipal officials. The Massachusetts Department of Environmental Protection (MassDEP) will continue to update this document and these resources as new information becomes available. # **Solid Waste and Recycling Essential Services Designation**

Governor Charlie Baker <u>issued an emergency order</u>, which was extended, requiring all businesses and organizations that do not provide "COVID-19 Essential Services" to close their physical workplaces and facilities to workers, customers and the public as of Tuesday, March 24th at noon until Monday May 4th at noon. Essential Services included the support to ensure the effective removal, storage, and disposal of residential and commercial solid waste and hazardous waste. This includes all activities related to the handling of waste materials for recycling, composting or disposal.
