Downtown/Main Street Working Group

- May 27, 2020 Chatham Chamber of Commerce/Merchants Association approached the BOS with a suggestion of changing traffic and pedestrian flow along Main Street to better promote social distancing – One way vehicular and pedestrian flows
- Concerns were raised during the meeting and by the Police and Fire Chiefs and DPW Director about safety issues with the proposal
- BOS felt that some sort of change warranted further discussion and asked the Town Manager to convene a working group to explore options



Downtown/Main Street Working Group

- Working Group consists of Town Staff including TM, CD & DPW Director, Police & Fire Chiefs, Health Agent, Rep from the BOS, Planning Board, Historic Business District Committee, Neighborhood Rep and members of the Chamber and Merchants Association 19 members
- The Group held meetings through Microsoft Teams to discuss ideas
- A site walk was conducted by the group where members were able to offer ideas and listen to each others concerns
- The Group agreed that changing pedestrian and traffic flow would not only cause confusion, it could lead to enforcement issues



Downtown/Main Street Working Group

- 133 Parallel Parking Spaces (Undesignated/Free)
- Group decided on "repurposing" parking along Main Street, 14 spaces are reserved for "Curbside Pick-Up" and the group chose to temporarily eliminate 4 parking spaces around areas where pedestrians are known to congregate.
- June 16, 2020 Recommendations approved by the BOS
- The Working Group will continue to meet weekly throughout the summer to evaluate the changes and further refine the plan if necessary

Outdoor Dining Policy

- The Town Manager created an internal working group of staff to recommend a BOS policy and guidelines relating to outdoor dining
- The group had a recommendation to the BOS within a week of being convened –June 9, 2020
- Group meets twice a week as needed to review applications to ensure life and public safety requirements are met
- BOS reviews any application that requires an Alteration of Premises
- BOS has held special meetings as needed to accommodate the applicant and help to get the businesses open ASAP
