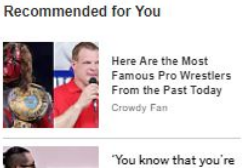

Federal Broadband and Digital Equity Funding Landscape

- Statewide Mapping Effort
 - Identify remaining unserved and underserved homes
 - Support FCC broadband coverage challenge process
 - Inform targeted investments in broadband infrastructure
 - FCC releasing new coverage maps on November 18.
- State ARPA Digital Equity Fund - \$50M
 - Build local/regional capacity in digital equity planning.
 - Implement digital equity projects.
- US Treasury Capital Projects Fund - \$175M
 - Expand access to reliable broadband service.
 - Gap Networks Infrastructure Grant Program - \$145M allocation
 - First priority is to “connect the unconnected”
- NTIA Digital Equity Act Planning Grant
 - Support a yearlong statewide digital equity planning effort.
 - Engage stakeholders, analyze data, build strategies to close the digital divide.
 - Design and implement systems to deploy DEA capacity grants.
- NTIA Broadband Equity, Access, and Deployment Initial Application Grant
 - Develop a 5 Year Action Plan for deploying BEAD funds.
 - Prepare a state challenge process.
 - Design and implement systems to deploy BEAD grants

Massachusetts allocations for IIJA (Digital Equity Act and BEAD) broadband funding have not been announced.

\$50M State Digital Equity Fund

Overview

- Established under State ARPA Authorization – Funds must be committed by 12/31/2024 and expended by 12/31/2026
- Administered by MBI through a contract with the Commonwealth
- Will initially support two programs

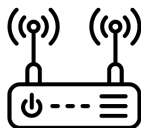

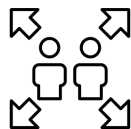

Municipal Digital Equity Planning

Overview

- MBI is funding Municipal Digital Equity Planning Activities
 - **Charrette Model** – Similar to Municipal Vulnerability Planning Program
 - **Planning Model** – Similar to a Master Plan Chapter, or Economic Development, HPP, OSRP, or other topic specific planning activities.
- Available for individual municipalities, but regional collaboration is encouraged.

Program Goals

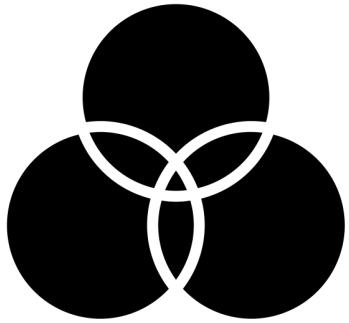
- Guide **municipal decision-making** related to services and infrastructure that will increase access, adoption and usage of the internet for the populations most impacted by the COVID 19 pandemic.
- Prepare municipalities to **submit grant proposals** to existing or forthcoming state or federal programs to support digital equity activities.



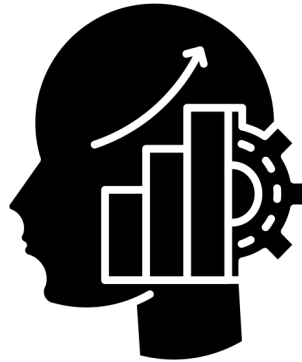

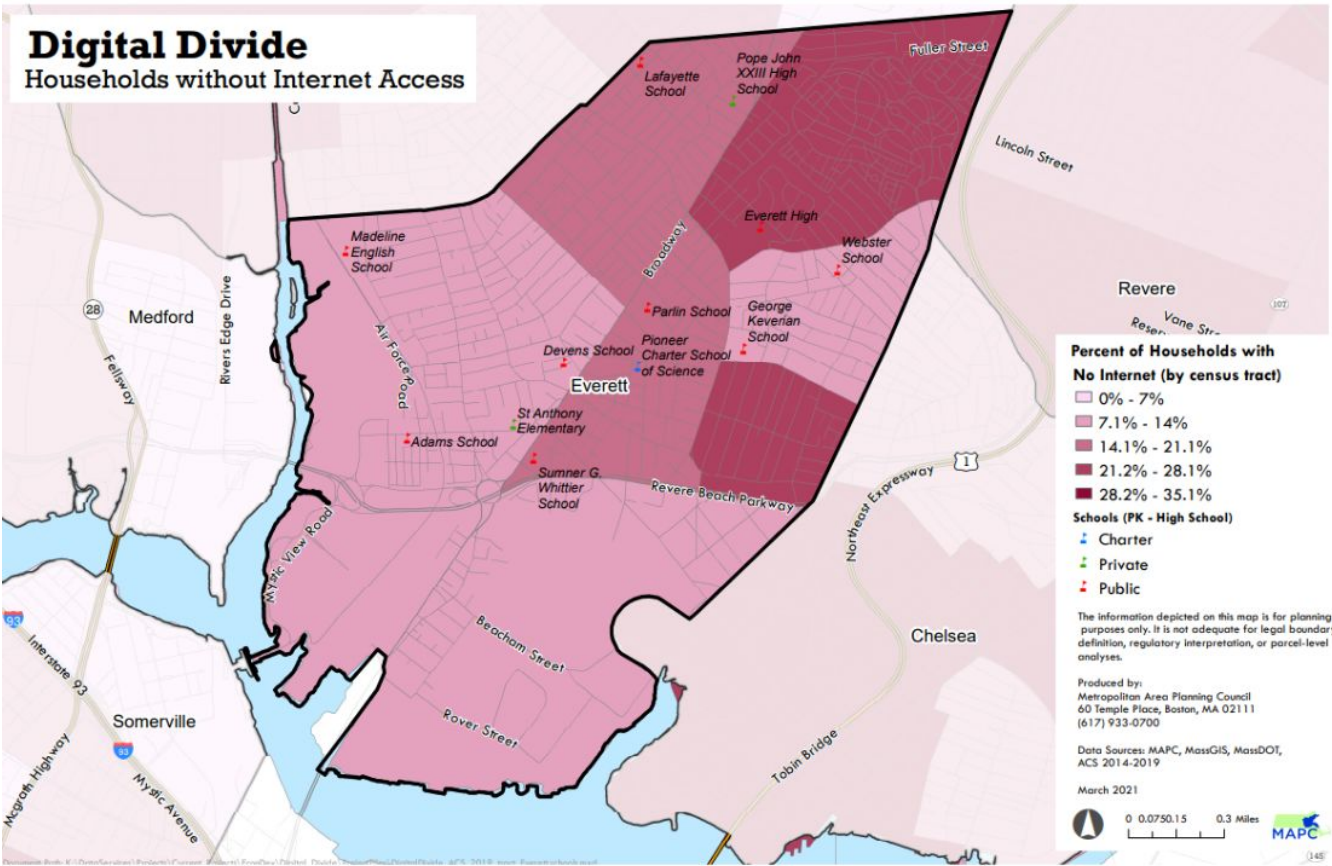

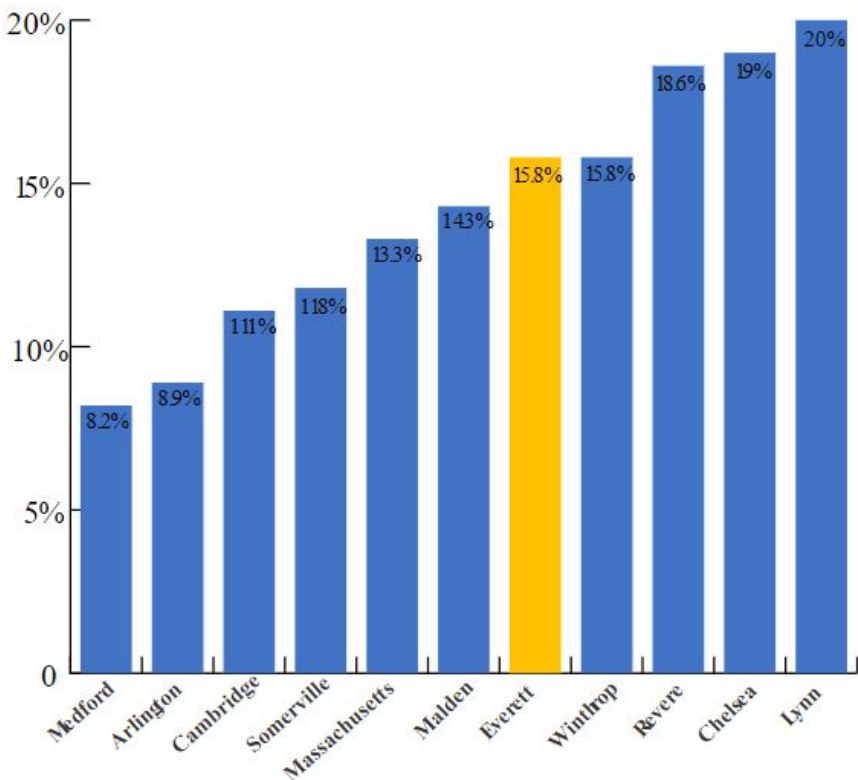

Existing Conditions Analysis



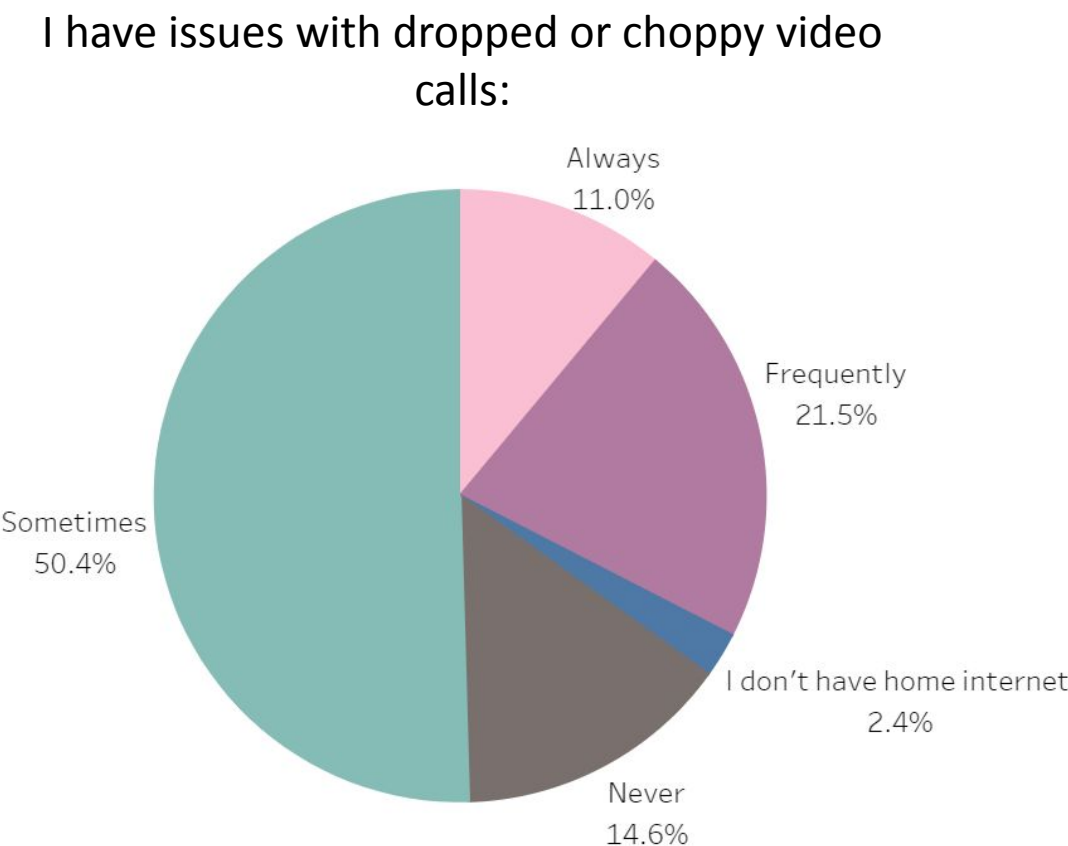
Percent of Households without Internet Access

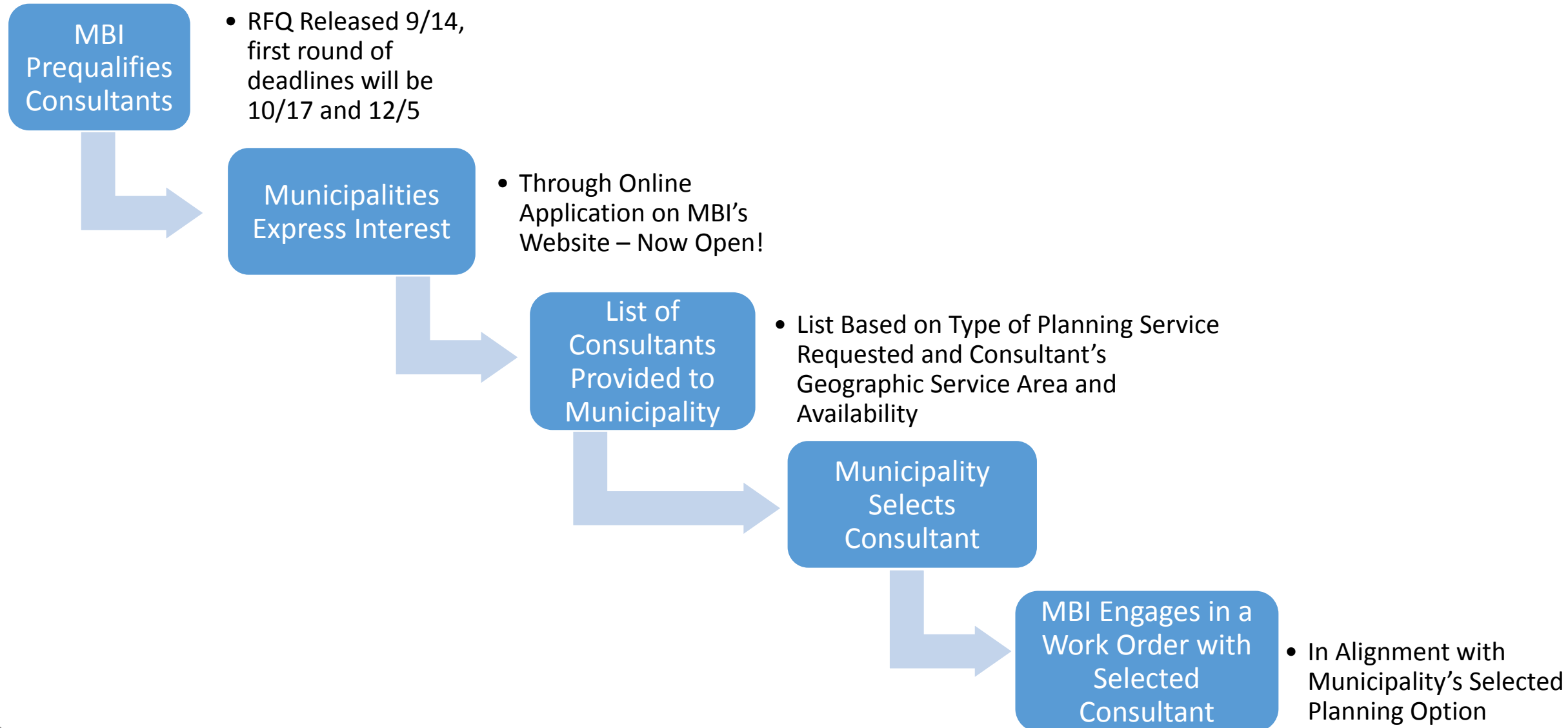

Municipal Digital Equity Planning



Online Application Requirements

Basic Information

- Contact Info
- Municipality or Region applying
- Total population covered
- Plan / Charrette option
- Desired start/end date

“Impacted” Populations Data*

- % total pop at or below 300% federal poverty line
- Names of schools qualifying to receive universal free lunch
- HUD “Qualified Census Tracts”

Community Context

- Why a digital equity plan now?
- Desired activities/processes?
- Desired outcomes consultants should be aware of?
- List of key stakeholders
- Description of any existing digital equity programming
- Description of any complimentary planning activities

Municipal Support

- Signed letter by municipal CEO
- Designated municipal “lead” staff member
