


### Grants are not the panacea...

- Grant Applications: This can be taxing and take up a lot of staff time and effort. Municipal organizations need to be strategic when going after outside funding sources.
- Competition: Competition for grants is fierce! We all are going after the same funding sources. A solid vision, political capital, and a well-thought out application and financing strategy will set you apart from the others.
- Strings Attached: All grants come with strings attached or have strict eligibility requirements.
- Complex Reporting: Grants, especially from the Federal government require complex reporting and data and metrics tracking.
- Short Term: Grants are often short-term in nature and are project focused. Grant-funded municipal positions can lead to future budget angst when funds expire.

Hudson was awarded a \$650,000 MassWorks grant in Decen HUDSON - The downtown rotary will soon get a long-awaited facelift.

Hudson was awarded a \$650,000 MassWorks grant on Tuesday to revamp the rotary, making it safer for vehicle and pedestrian traffic -- a priority of town officials for many years. The grant award was announced in a press release.

Improvements will include better-defined driving lanes, raised crosswalks, new landscaping, benches and lighting. The upgrades will improve pedestrian access, enhance the downtown's appearance, provide more sidewalk space for outdoor dining and help sustain the downtown revitalization that has brought numerous shops, restaurants and nightlife to Hudson's Main Street.

Jack Hunter, planning and community development director, believes the project will make the historic rotary the focal point of the town center. Hudson recently reconstructed the nearby Washington Street bridge and South Street.

# KJ's GRANT PRO-TIPS



- Be strategic: Don't apply for every grant opportunity to see what sticks.
- Don't expect a grant to pay for your entire project; build a comprehensive, multi-faceted financing strategy.
- Get to know your municipal finance department colleagues.
- Consider how your project grants affects other municipal departments: Public Works, Public Health, etc.
- If you have consultants under contract, use them for grant preparation.
- Bring your elected officials on Board; they can be your strongest advocates.
- Attend all pre-grant trainings and webinars, especially for new programs.
- Meet with Commonwealth agencies and your Regional Planning Agency to discuss your ideas.
- Chat with a fellow colleague; many of us have "been there, done that."
