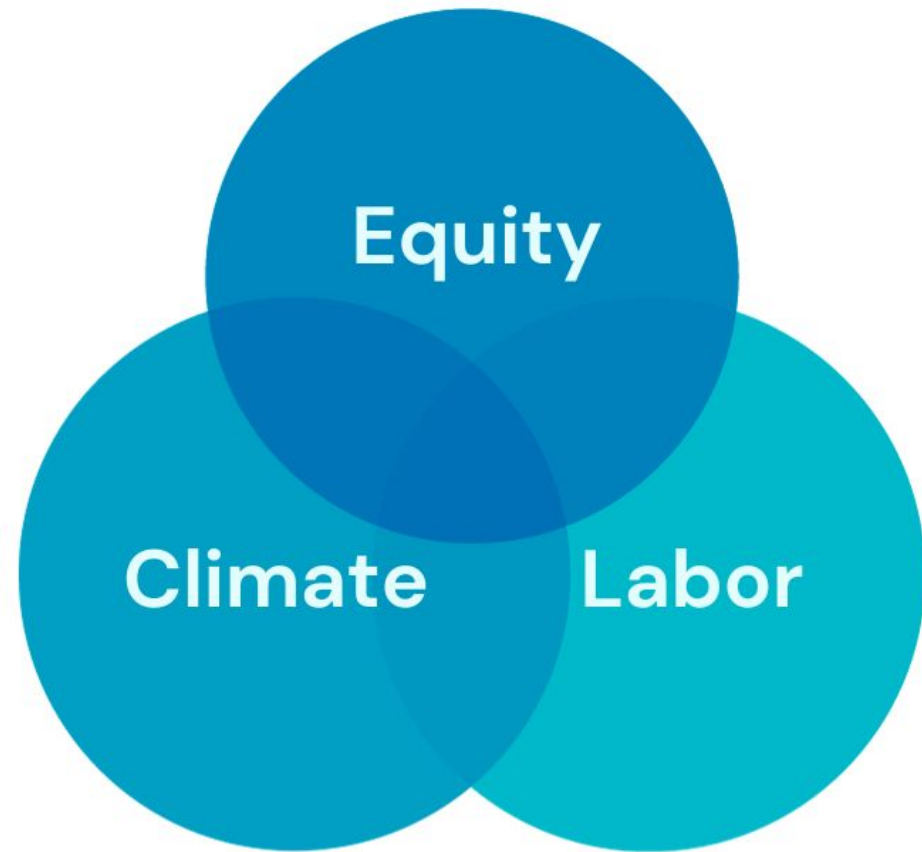

I hope you're having a great November! The Federal Funds and Infrastructure Office (FFIO) would again like to thank everyone who made our first Municipal Partnership Meeting on 10/28 a huge success. Over 325 people attended that meeting, and we hope you will join us for our **upcoming meeting on November 28<sup>th</sup> from 2-3pm** (if you haven't registered already for our monthly Zoom meetings you can do so [here](#), the same link can be used for each meeting).

In this newsletter, you will find:

1. **The agenda for our next Municipal Partnership Meeting on November 28<sup>th</sup> meeting**, which will include presentations from experts on the following federal funding opportunities:
  - a. Building Resilient Infrastructure & Communities (BRIC) and Flood Mitigation Assistance (FMA); and
  - b. Climate Pollution Reduction Grants (CPRG)
2. **Federal funding opportunities** with links to relevant contacts, including more information on the above grants; and
3. **Additional resources**, including information on technical assistance opportunities.

**But first, here's a brief update on a couple of major wins Massachusetts has secured for critical projects and programs.** Most recently, the [New Bedford Port Authority \(NBPA\) was awarded \\$24.4 million](#) of Port Infrastructure Development Program (PIDP) funding towards the Leonard's Wharf Reconstruction & Extension Project, which is designed to mitigate sea levels, support the domestic offshore wind industry, and bolster the city's resiliency to climate change. Also in October, [MassDOT announced that approximately \\$4.6 million](#) will be awarded to four municipalities – [Brockton](#), [Haverhill](#), [Lowell](#), and [Somerville](#) – as part of the first round of awards for the U.S. Department of



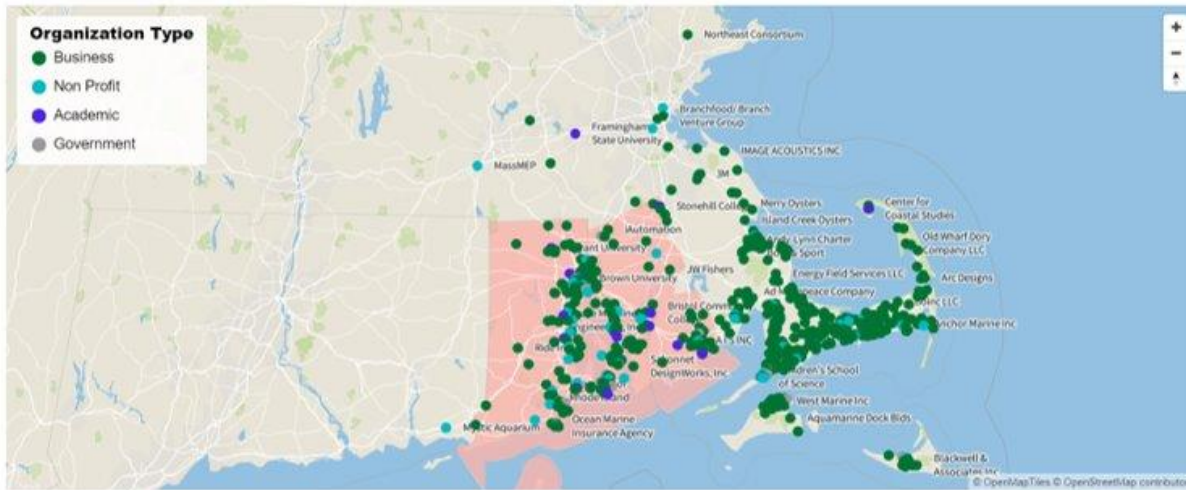
# STATE MATCHING FUNDS / TECHNICAL ASSISTANCE LEGISLATIO N

- Bill [S.2548](#) *An Act to provide for competitiveness and infrastructure investment in Massachusetts*, includes:
  - Creates a Commonwealth Federal Matching and Debt Reduction Fund that leverages interest earnings on the state's Stabilization Fund
  - Over the next three years, fund **will unlock an estimated \$800 million** in resources to pursue federal funding opportunities
  - **\$50 million matching grants and loans** for a local government infrastructure bank
  - **\$12 million** towards local government technical assistance
  - **Adds to the over \$2 billion** in existing resources Massachusetts has made available for state match to give Massachusetts a competitive edge in the pursuit of historic federal grant opportunities
- Passed unanimously by the Massachusetts Senate on Thursday, January 11th



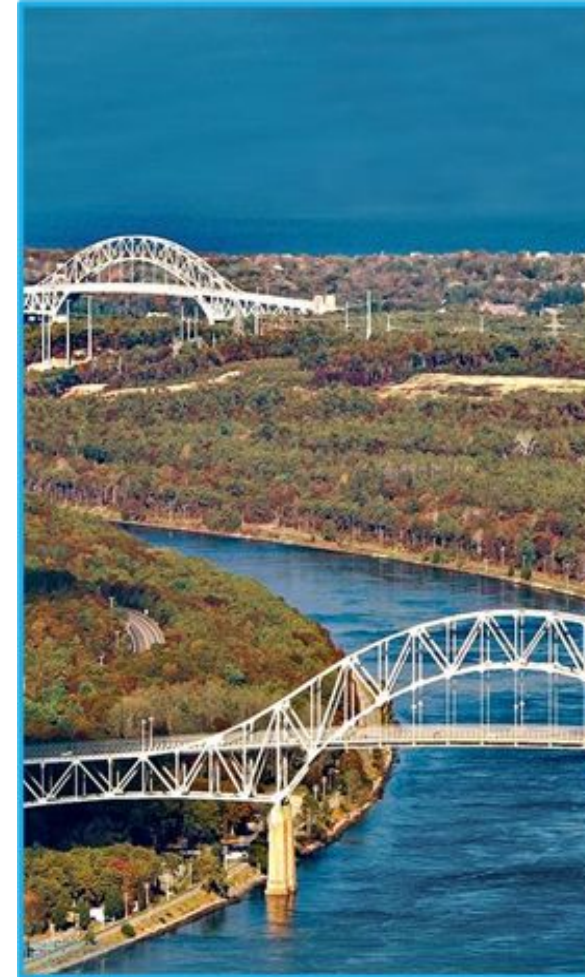
# SUCCESSFUL GRANT APPLICATIONS

The Southeastern New England Consortium for Ocean Technology



## Ocean Tech Hub

Designation awarded to RI and Southeast MA with the potential to unlock \$50-75 million in funding from the EDA Tech Hub program for projects that advance ocean technology innovation



## Cape Bridges

\$372 million awarded from the Multimodal Project Discretionary Grant program, and a request for an additional \$1.06 billion from the Bridge Investment Program currently pending

# SUCCESSFUL GRANT APPLICATIONS

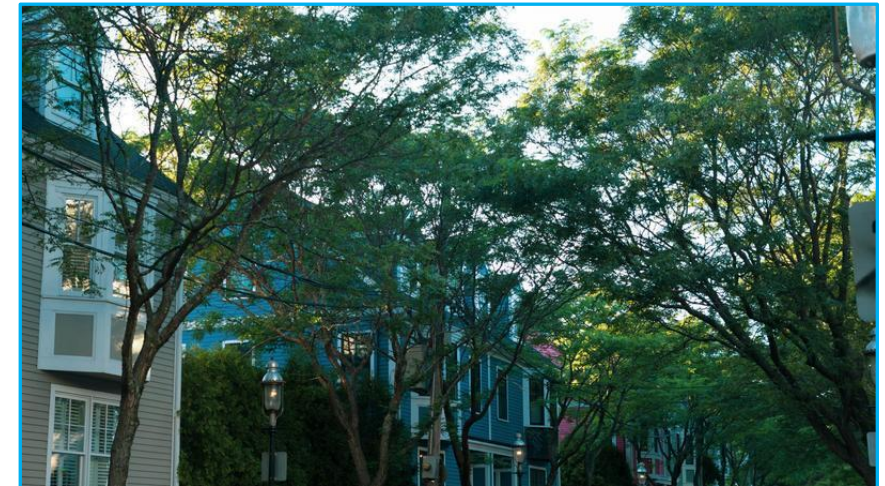


**Broadband Equity, Access, and Deployment (BEAD) Program**

Awarded \$147 million to expand high speed internet access

## **Northeast Microelectronics Coalition Hub (NEMC)**

Awarded \$19.7 million in CHIPS and Science funding for a DoD microelectronics regional hub that includes a coalition of 90 organizations from across the Northeast assembled and led by the Massachusetts Technology Collaborative



## **USDA Urban and Community Forestry Program**

9 municipalities awarded \$22 million to increase urban tree canopies to combat extreme heat and improve access to nature

# SUCCESSFUL GRANT APPLICATIONS



**Early Action Items for new AMTRAK Inland Rail Route**  
\$108 million in Consolidated Rail Infrastructure and Safety Improvements (CRISI) Program funding for a new AMTRAK Inland Rail Route from Boston to New Haven, CT via Worcester and Springfield.

## **Leonard's Wharf Rehabilitation and Extension Project in the Port of New Bedford**

\$24 million in federal funds from the Port Infrastructure Development Program combined with \$18 million in state matching funds to rebuild and extend Leonard's Wharf to allow for its continued use as a commercial fishing pier, expand its capacity for use in staging offshore wind projects, and increase its climate resiliency by raising the wharf to account for sea level rise.

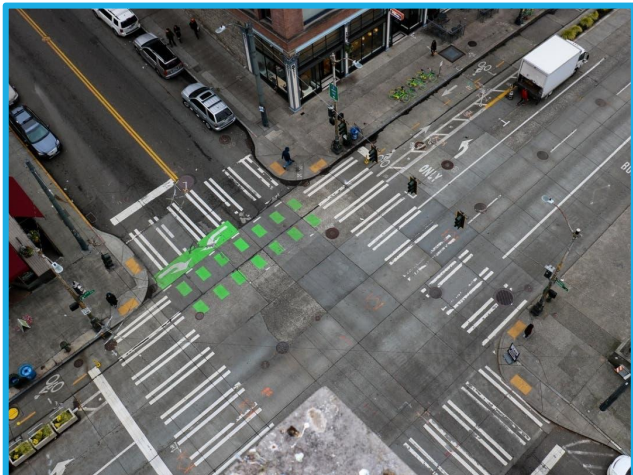


## **Clean School Bus Program**

\$33 million from the EPA Clean School bus program for 85 electric buses in Boston, Worcester, New Bedford and Fall River.

## **Shelter and Services for Migrant Families**

\$1.9 million from the Federal Emergency Management Agency (FEMA) to expand shelter services and transportation in Massachusetts for newly arrived migrant families



## **Safe Streets and Roads for All**

\$22 million in awards to Massachusetts communities for street safety planning and implementation, including funding to the City of Boston for traffic signal operations design, the City of Somerville for their Bicycle Network planning, and for projects led by 13 other Regional Planning Agencies and municipalities.



## **Workforce Training in Berkshire County**

\$1 million in funding for workforce training in communities affected by opioid crisis

## Allston Multimodal

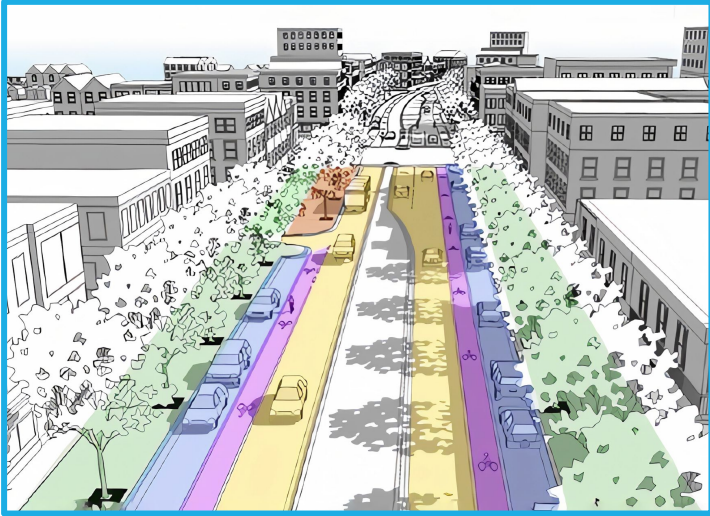
Seeking \$500M in resources from the Reconnecting Communities and Neighborhoods program to support the ~\$1.9B project to replace the Allston interchange, increase access to multimodal transportation and improve community connectivity.

## Solar for All

Submitted joint application between the Massachusetts Department of Energy Resources (DOER), the Massachusetts Clean Energy Center (MassCEC), MassHousing, and the Boston Housing Authority requesting clean energy investments for up to 78,500 low-income and affordable homes from the EPA's Greenhouse Gas Reduction Fund



# PENDING GRANT APPLICATIONS



## Technical Assistance for Transit-Oriented Development

Applied to the Thriving Communities program seeking \$2M to build capacity for the development of transit-oriented neighborhoods along Massachusetts Route 2 in Worcester and Franklin Counties



## Flooding on Morrissey Boulevard (Dorchester)

Submitted PROTECT application seeking \$2.2M in BIL resources to support a \$2.75M project to construct a stormwater pump station to provide effective drainage and flood control to the area



## Worcester Route 20 and Grafton St Interchange Flooding

PROTECT application seeking \$3.7M for the Route 20 and Grafton St (Route 122) interchange to replace and expand outdated drainage systems for a major intersection that experiences flooding between 6 and 10 times a year during heavy rainfall.

# CLEAN SCHOOL BUS REBATES PROGRAM

## □ **About the program:**

- The clean school bus rebate program offers rebates to public school districts and third-party transportation providers to replace existing buses with clean, zero emission alternatives.

## □ **Funding information:**

- Upwards of \$500M available for this round of funding
  - 60% of awards will go to priority districts
  - There will be a minimum of 1 award per state

## □ **Eligibility:**

- Public School Districts and Private Transportation Providers

## □ **Deadline: 1/31/2024**

# REBUILDING AMERICAN INFRASTRUCTURE WITH SUSTAINABILITY AND EQUITY (RAISE)

- Eligibility: State, Tribe, Local Government
- Total Funding: \$1,500,000,000
- Cost Share: 20%
- About
- “The goal of the RAISE program is to fund eligible surface transportation projects that will have a significant local or regional impact that advance the Departmental priorities of safety, equity, climate and sustainability, and workforce development, job quality, and wealth creation”
- Deadline: 2/28/2024

# GREEN AND RESILIENT RETROFIT PROGRAM (GRRP)

## □ **About the program:**

- The GRRP program “provides funding for projects that improve energy or water efficiency, enhance indoor air quality or sustainability, implement the use of zero-emission electricity generation, low-emission building materials or processes, energy storage, or building electrification strategies, or address climate resilience, of eligible HUD-assisted multifamily properties.”

## □ **Funding information:**

- Funding varies by award type, ranging from \$40K per unit up to \$20M per property

## □ **Eligibility:**

- Projects must be on HUD-assisted multifamily properties

## □ **Deadline:**

- Elements – 3/28/2024
- Leading Edge – 4/30/2024
- Comprehensive – 5/30/2024

# ENVIRONMENTAL AND CLIMATE JUSTICE COMMUNITY CHANGE GRANTS PROGRAM

## □ **About the program**

- These grants provide approximately \$2 billion dollars in Inflation Reduction Act funds to benefit disadvantaged communities through projects that reduce pollution, increase community climate resilience, and build community capacity to address environmental and climate justice challenges.

## □ **Funding information:**

- The grant program has two tracks—one that will award \$10-20 million grants on climate action and pollution reduction, and one that will award \$1-3 million grants to support the engagement of environmental justice communities in governmental processes
- **Note:** Technical assistance for the application itself may be available to eligible applicants.

## □ **Eligibility:**

- Requires either a partnership between two community-based non-profit organizations (CBOs), or
- A partnership between a CBO and a Federally-Recognized Tribe, a local government, or an institution of higher education.

## □ **Deadline: Rolling until November 2024**
