



PUBLIC SERVICE LOAN FORGIVENESS

PSLF is a federal program designed to forgive the remaining balance on eligible federal student loans for borrowers who work full-time for qualifying public service employers after they make 120 payments.

As of July 2025, 3.3% of PSLF applications have been accepted since November 2020.

ENROLLMENT REQUIREMENTS

1) Enroll into an **Income-Driven Repayment Plan (IDR)**

- Select best IDR plan for you
- Complete 10-page application
- Recertify enrollment annually

2) Complete the **Employee Certification Form**

- Complete 6-page application
- Have it Signed by Employer
- Recertify enrollment annually

3) Complete the **PSLF Application**

- Make 120 qualifying payments
- Submit 6-Page Application
- Signed by Employer
